A. COURSE DESCRIPTION

Personal and family accounts, budgets and budgetary control, bank accounts, charge accounts, borrowing, investing, insurance, standards of living, renting or home ownership, and wills and trust plans.

B. PREREQUISITE: None.

C. CREDIT: Lecture - 3; Lab – 0

D. CORE CURRICULUM: This course partially satisfies the Core Curriculum Requirement for Social and Behavioral Science Foundational Component Area (080).

E. CORE CURRICULUM OBJECTIVES ADDRESSED:

Communications skills—to include effective written, oral and visual communication

Critical thinking skills—to include creative thinking, innovation, inquiry, and analysis, evaluation and synthesis of information

Empirical and quantitative competency skills—to manipulate and analyze numerical data or observable facts resulting in informed conclusions

Personal Responsibility—to include the ability to connect choices, actions, and consequences to ethical decision-making.

Social Responsibility—to include the demonstrated knowledge and competence, knowledge of civic responsibility, and the ability to engage effectively in regional, national, and global communities

F. STUDENT LEARNING OUTCOMES:

1. Identify the concepts associated with the time value of money.
2. Identify the differences among various savings and investment programs and classes of securities.
3. Identify the options for insurance

4. Describe retirement and estate planning techniques.
5. Explain the benefits of owning versus renting real property.
6. Discuss consumer protection legislation.

G. STUDENT LEARNING OUTCOMES ASSESSMENT: This will vary and is geared towards Task Stream and WECM standards. This course will be assessed on an annual basis.

H. ATTENDANCE POLICY: As an online class, students will be required to access the course on a regular basis. **Minimum log in for this course is three (3) days per week.** The Blackboard software used to manage this online course tracks student logins. The instructor is able to track when and where the student has been in the course and the amount of time spend working on an assignment.

Accessing this course on a regular basis is extremely important in order to complete the required assignments. **Students that DO NOT log in to Blackboard each week will be dropped from this course with a grade of "F."** **Students that log in to Blackboard but DO NOT COMPLETE ASSIGNMENTS will not be dropped, but will receive the grade they have earned for the assignments that have been completed.**

When an unavoidable reason for class absence arises, such as illness, an official trip authorized by the college or an official activity, the instructor *may* permit the student to make up work missed. It is the student's responsibility to complete work missed within a reasonable period of time as determined by the instructor. Students are officially enrolled in all courses for which they pay tuition and fees at the time of registration. Should a student, for any reason, delay in reporting to a class after official enrollment, absences will be attributed to the student from the first-class meeting.

Students who enroll in a course but have "Never Attended" by the official census date, as reported by the faculty member, will be administratively dropped by the Office of Admissions and Records. A student who does not meet the attendance requirements of a class as stated in the course syllabus and does not officially withdraw from that course by the official census date of the semester may be administratively withdrawn from that course and receive a grade of "X" or "F" as determined by the instructor. Instructors are responsible for clearly stating their administrative drop policy in the course syllabus, and it is the student's responsibility to be aware of that policy.

It is the student's responsibility to verify administrative drops for excessive absences through MySPC using his or her student online account. If it is determined that a student is awarded financial aid for a class or classes in which the student never attended or participated, the financial aid award will be adjusted in accordance with the classes in which the student did attend/participate and the student will owe any balance resulting from the adjustment.
